Terms and Conditions

THIS LANDSCAPE SERVICE AGREEMENT (this "Agreement") is entered into as of **06/07/2021** between White Diamond Landscape and **Center Gate Estates Village** - **Section III** If Client is other than the record owner of each property where goods or services will be delivered under this Agreement, then the Client is executing and entering into this Agreement on its own behalf and as duly authorized agent for the record owner(s) of those properties.

NOW, THEREFORE, Client and White Diamond mutually agree to the following items and conditions: of multiple Landscape Sites. During the

term (defined

1. Services. For the purposes of this Agreement: (i) the "Services" consist of the landscape maintenance, construction, irrigation, and other general landscape services described in the "Scope of Landscape Services" attached hereto, together with delivery or installation of any associated goods and materials, and (ii) the "Landscape Site(s)" consist of the exterior landscape areas for each of the site(s) identified in the attached Scope of Landscape Services, where Services will be furnished by White Diamond in accordance with the

Scope of Landscape Services. More than one Scope of Landscape Services may be attached Hereto in the event below) White Diamond shall furnish the services or arrange for the services to be furnished in accordance with applicable professional horticulture standards and any local requirements or regulations in effect, using appropriately trained, uniformed, and supervised personnel, and the properly maintained equipment. All tools, equipment, surplus materials, landscape waste materials and rubbish will be removed from each

Landscape Site after Services are completed. Any regulated substances required to be applied as part of the Services shall be applied in accordance with applicable laws and regulations by properly licensed personnel. Other materials shall be applied in

personnel. Other materials shall be applied in

accordance with the manufacturer's directions

- 2. Term. The "Initial Term" of this agreement shall start in 2021 and end on TBD. Thereafter, this Agreement shall renew automatically for successive one year periods (each, a "Renewal Term") on each anniversary of the start date of the initial term (each an "Anniversary Date") with an agreed 3% increase per term, unless either party gives written notice to the other party of its intent not to renew at least 90 days prior to the next Anniversary Date. The initial term, together with any Renewal Term, compromises the "Term."
- 3. Work Orders. If Client requests services from White Diamond that are not set forth on the Scope of Landscape Services or at a worksite for which there is no attached Scope of Landscape Services, the White Diamond may elect in its

agreement to any company which controls, Is controlled

before, during, or after Services performed or Work Order services are performed and, consequently, Client shall not rely on White Diamond to provide any such assurances at any time. If Client desires safety evaluation, inspection, or consulting services, or safety representations, warranties, or assurances, then White Diamond may execute and enter into a separate written agreement whereby White Diamond will assist Client for an additional fee only in identifying (without recommending) third-party service providers that Client may then, in Clients sole discretion, elect to engage independently to obtain safety services and/or assurances.

- (b) This agreement shall be governed by the law of the state where the Services will be furnished. If the services are furnished in more than one state, then the law of the Commonwealth of Florida will govern this agreement, except with regard to its conflicts of laws doctrines. Both parties expressly agree that any and all legal proceedings arising under this agreement will be brought exclusively in the state and federal courts located in the Commonwealth of Florida.
- (c) Neither party may assign this agreement without the prior written consent of the other party; provided, however, that consent shall not be required to assign this by, or is under common control with White Diamond or in connection with assignment to an affiliate or pursuant to a merger, sale of all or substantially all of its assets or equity securities, consolidation, change of control or corporate reorganization. This agreement is binding on, and ensures to the benefit of, the parties hereto (including the record owner of the Landscape Site(s) if other than Client) and their respective heirs, legal representatives, successors and assigns.
- (d) This agreement, together with any attached Billing Information and Schedule, attached Scope of Landscaping Services, Work Order hereunder, and any other schedules and exhibits attached hereto, constitute the entire agreement of the parties with respect to the Services and Work Orders and supersedes all prior contracts or agreements with respect to the Services or Work Orders, whether oral

For services, goods, or materials furnished pursuant to a Work Order, payment shall be due from Client to White Diamond as specified by such Work Order, if

5. General Provisions.

(a) White Diamond will at all times perform the Services and any Work Order in accordance with all applicable workplace safety requirements and standards promulgated by federal and local authorities. White Diamond will not at any time provide safety evaluation, inspection, or consulting services under this agreement or any Work Order for the benefit of Client or any third party and, consequently, Client shall not rely on White Diamond to provide such safety related services at any time. Further, White Diamond does not and will not at any time provide representation, warranties, or assurances as to the safety (or lack of safety) of any Landscape Site(s) or Work Order site with respect to periods before, during, or after Services performed or Work Order safety evaluation, inspection, or consulting services, or safety representations, warranties, or assurances as to the safety (or lack of safety) of any Landscape Site(s) or safety representations, warranties, or assurances as to the safety (or lack of safety) of any Landscape Site(s) or Work Order site with respect to period

- (e) Except as otherwise provided herein, this agreement may be amended modified from time to time only by a

For purposes of this Agreement, the parties agree specifically that water conservation regulations or guidelines are specifically included within the above referenced regulations or restrictions, and that White Diamond shall not be liable for any failure to perform as a direct or indirect result of White Diamond's compliance with or good faith efforts to comply with state or local water regulations on mandates. 6. **Termination.**

- (a) Either White Diamond or Client may terminate this Agreement without cause upon 30 days prior written notice to the other party. Once a 30-day written notice is received, invoicing will be adjusted by White Diamond to reflect termination.
 - (b) If either party materially breaches the terms of this agreement and fails to cure such breach within 30 days after written notice from the non-breaching party specifying such breach, then the non

If termination of services is before the contract closure 5% will be due for the remainder of the contract owed. All products used in Property are purchased from professional lawn product vendors. All services are rendered on an as needed basis, weather permitting.

Standard Warranty

White Diamond agrees to Warranty irrigation, drainage and lighting for 1 year, trees and palms for 6 month, shrubs and ground cover for 3 months, and sod for 30 days. This warranty is subject to and specifically limited by the following: Warranty is not valid of relocated material, annuals and existing irrigation, drainage, and lighting systems. Warranty is not valid on new plant material or sod installed without automatic irrigation. Warranty does not cover damage from pests or disease encountered on site, act of God or damage caused by others. Failure of water or power source not caused by White Diamond will void warranty. The above identified warranty periods commence upon the date of completion of all included in this proposal. Standard Warranty does not modify or supersede any previously written agreement.

White Diamond is not responsible for damage to non-located underground items.

Detailed Scope of Landscape Services

Scope of Work:

Contractor shall furnish all horticultural supervision, labor, material, equipment and transportation required to maintain the landscape throughout the contract period, as specified herein.

Lawn Care:

Mowing and Edging:

Lawns shall be mowed more frequently during the active growing season of May through October and bi-weekly during the slow growing season of November through April. During extended rainy or dry periods mowing will take place as conditions dictate. Mowing height will be based on what is horticultural correct for the turf variety considering the season. Clippings shall not be caught and removed from lawn areas unless they are lying in swaths which may damage the lawn.

Edges shall be trimmed to maintain a neat appearance. All hard surfaces shall be edged at every mowing. All soft surfaces, landscape beds, shall be edged every other visit to maintain a clean edge.

Disease Control:

Disease control is maintained through proper fertilization, mowing and water management. In the event that disease problems occur, contractors will use treatments to stop or slow progression of disease. This program does not include the prevention of disease with weekly or monthly applications of disease control products although such protection is available at substantial additional cost.

Weed Control:

Contractor will use proper fertilization, mowing and watering practices to promote the growth of weed resistant turf. Additionally, applications of pre and post emergence weed controls will be applied at times if warranted to control weeds without damaging desirable turf. Recent changes in federal regulations have resulted in our loss of ability to selectively control some weeds including crabgrass when they are present in St Augustine. The only

control of these weeds is to treat infested turf with non selective products such as Roundup. The treatments require the re-sodding which will be quoted at additional charge.

Ground Cover Area/Shrub Area:

Edging:

Edge ground cover as needed to keep within bounds and away from obstacles.

Pruning:

Shrubs shall be pruned only as necessary to maintain the natural form of the plant, to maintain growth within space limitations, and to eliminate damage or diseased wood. This excludes pruning necessitated by storm damage, disease, neglected overgrowth or winterkill.

Weed Control:

Keep beds reasonably free of broadleaf or grassy weeds, preferably with pre-emergent and/or selective post-emergent/contact herbicides.

Pre-emerge: This type of control should be used only if a known weed problem warrants its use. Post-emerge: Control broadleaf weeds with selective herbicides.

The chosen chemical will be recommended and legally approved for the specific weed problem.

Irrigation:

Irrigation System:

Watering shall be scheduled with automatic controllers to supply quantities and frequencies consistent with seasonal requirements of the plant materials in the landscape. In some circumstances, water scheduling may be limited by local watering restrictions.

Where practical, watering shall be done at night or early morning if the system is automatic, unless notified otherwise by the owner.

Any damages to the irrigation system caused by the Contractor while carrying out maintenance operations shall be repaired without charge. Where practical, repairs shall be made within one watering period.

Faulty equipment, vandalism or accidental damage caused by others shall be reported promptly to the owner. Cost of labor and material to perform repair is an extra and shall be paid for by the owner upon authorization.

Whenever possible, the owner's representative shall be instructed on how to turn off the system in case of emergency. Our office is to be advised at once or by the next business day.

If the Contractor is required to make emergency repairs or adjustments on other than regularly scheduled visits, a minimum charge of \$55.00 per hour for emergency calls will apply.

Tree Care:

Pruning:

Height limitation for tree pruning covered in the specifications is 15 feet. On trees over 15 feet in height only low-hanging branches that present a hazard to pedestrian or vehicular traffic will be raised on limbs no more than an inch in diameter. Palms under 15 feet are scheduled to be pruned as needed to keep dead limbs with the normal detail visits. Safety related pruning of trees under fifteen feet will be performed only when necessary.

Staking:

Stakes are to be inspected and adjusted or removed as necessary. When trees attain a trunk caliper of 4" or substantial root development stability, removal will be discussed with the client.

Additional Services:

Debris Cleanup:

All landscape areas shall be inspected on days of service and excess debris removed. Gardening debris, generated from our work, shall be removed from paved areas on days of service. This excludes heavy leaf fall pickup from parking areas, sidewalks, pools, etc. Please refer to the price page for details. Any excess debris cleanup including additional

tree work as not covered under this Agreement will be quoted upon request and will include a 10% dump fee.

Palm Pruning: Over Fifteen Feet Optional, Quoted Upon Request:

Dead or dying fronds should be removed annually. It is best to leave healthy fronds when possible and defer to specific pruning methods and finished cuts per palm type.

Mulched Area:

Mulched areas will be inspected on our days of service. Weeds and grasses shall be controlled with recommended, legally approved herbicides only if necessary. In those areas with excessive mulch build up alternatives will be discussed with the client.

Mulch beds will be replenished with a 2-inch depth of mulch annually. In those areas with excessive mulch build-up, alternatives will be discussed with the client. Please refer to the price page for details.

Annual Color; Optional, quoted upon request:

Contract grown flowers can be installed every three months at a cost of \$1.75 per plant. Specified varieties, size, spacing and frequency will be recommended per climate and location of plantings. A 90- day warranty on plant life is applied excluding vandalism, acts of God, or irrigation related issues not due to contractor negligence or response time.

Landscape Design Services:

Should Client's property require new landscaping beds, or revisions to existing landscaping beds and require our professional design services, designing will be charged at \$75 per hour. Payment for design services will be credited to your final invoice upon completion of the job.

Sod Installation:

Should Client's property require new sod installation, pallets of sod are priced between \$150-430 depending on the type of sod required. Installation is \$150 per pallet regardless of type of sod required.


